After careful consideration, the Government is now pleased to amend Applicability para referred to in G.R. read at (6), as under –

1. Para 4. Applicability

This scheme shall be applicable only to a new industrial unit, or an existing industrial unit, who have already applied for registration on or before dt.24.7.2021 and that takes expansion and commences the commercial production on or before dt.24.07.2022.

2. The effect of this amendment shall be applicable to applications already received on or before dt.24.07.2021 and such pending applications will have to be reopened/relooked and approval be given by competent authority, if deemed fit.

Other terms and conditions will remain same.
